- 2. The Village updated the Well Head Protection Team members for the WHP plan.
- 3. The Village updated the Village's Website to include an environmental section containing articles and various links related to well head protection and storm water.
- 4. A copy of the Well Head Protection Plan and map has been placed on the Village's web site.
- 5. At the Sunset Homeowners annual meeting, discussion involved proper septic tank maintenance.
