

## Spring Clean-Up Drop Off Site

Saturday, May 9, 2020; 8 am – 2 pm <u>NEW PROCEDURE</u>: Spring clean-up is Drop off only (no longer Curb side) <u>LOCATION</u>: Garbage trucks will be at Wellhouse Drive near the Vicksburg Little League Senior Field at the back of the property to accept trash. <u>REQUIRED</u>: MUST be a village resident <u>AND</u> bring a Driver's License or State of Michigan ID to

bring a Driver's License or State of Michigan ID to prove village residency.

## The following <u>WILL</u> be accepted:

- Furniture and rolls of carpet must be four feet in length or less
- Trash Must be bagged or boxed and weigh less than 35 LBS
- Mattresses/box-springs must be sealed in plastic mattress bags
- Glass and mirrors should be boxed and marked
- All small items must be in bags or boxes

## The following **WILL BE REJECTED**:

- Appliances Stoves, refrigerators, dishwashers, freezers, air conditioners
- Hot tubs
- Construction debris, building materials or fencing
- Brush & yard trimmings (including leaves and grass clippings)
- Ammunition or fireworks
- Rocks, sand, dirt, sod, stumps, or concrete rubble
- Dead animals and pet waste
- Household hazardous waste (oil-based paints, liquid latex paints, gasoline, any type of battery, and pesticides. See <u>Disposal of Hazardous</u>
  Waste)
- Car parts or heavy iron and large plastic drums
- Major building materials generated from commercial projects
- Propane or helium cylinders
- Auto parts, engines, tires, batteries, oil, or gas
- Iron or steel, or cast-iron bathtubs

## Hydrant Flushing

The Department of Public Works will begin its hydrant flushing program starting early Saturday morning, **May 9, 2020.** The Department will be flushing select hydrants within the village on that day and will conclude by early afternoon. If your water is discolored or sediment appears during hydrant flushing, run your faucets until water runs clear. Avoid doing laundry until your water runs free of discoloration. For questions regarding hydrant flushing, call the Village Hall at 269-649-1919.



### Leaves and Brush

<u>Leaves</u> will only be picked up in bags. Grass clippings will <u>NOT</u> be picked up even if bagged. Brush is picked up the weeks of:

April 27 May 26 June 29

## <u>New Rates for</u> <u>Village Facility Rentals</u>

All of the above may have <u>half of the fee</u> <u>refunded</u> if all clean-up is done properly.

All parks in the village, the Recreation Area, and Bike Trail can be reserved at no charge but will not be for exclusive use with the reservation.



# Lawn Care

- Apply fertilizers only when necessary and at the recommended amount.
- Don't apply fertilizer before windy or rainy days.
- Apply fertilizer as close as possible to the period of maximum uptake and growth for grass and other plants, which is usually spring and fall in cool climate, and early and late summer in warm climates.
- Avoid applying fertilizer close to waterways.
- Do not overwater lawns and garden; use a soaker hose, a porous hose that releases water directly to the ground, which can reduce overwatering that carries away fertilizers that would otherwise enrich lawns and gardens.
- Fill fertilizer spreaders on a hard surface so that any spills can be easily cleaned up.
- Properly store unused fertilizers and properly dispose of empty containers.
- Maintain your lawn mowers, snow blowers, chain saws, leaf vacuums and similar outdoor power equipment to reduce nitrogen oxide emissions.
