Vicksburg Home Repair Program Guidelines

Applicants must:

- Complete and submit this application to South County Community Services
- Live in the Village of Vicksburg
- Own and occupy their home
- Be current on property tax payments
- Meet household income requirements. Eligible households must earn less than 60 percent of area median income (calculated with gross household income = total of pre-tax wages). Total household income includes all persons 18 years of age and older, unless full time student. Household income must not exceed the limits listed below.

We are unable to work on mobile homes, rental properties, homes in the process of being purchased through a land contract, or homes currently listed for sale. Work is financed through a 10-year, forgivable grant with pro rata repayment required if sold or transferred within the first ten years. The Village of Vicksburg reserves the right to select contractors and approve completed projects.
