## From the Village Manager:

### Prop 1 and Village Ordinance

As most of our residents know, this past November, voters in the State of Michigan passed Prop 1 (Michigan Regulation and Taxation of Marijuana Act). The Village of Vicksburg Village Council passed a Village ordinance at the December 17, 2018 Village Council meeting that prohibits marijuana establishments. Specifically, Article V, Section A states, "Pursuant to the provision of Section 6.1 of the Michigan Regulation and Taxation of Marijuana Act, marijuana establishments, as defined by the Act, are completely prohibited within the boundaries of the Village of Vicksburg." The Village Council requested that an expiration date (Jan. 31, 2020) be included within the ordinance. This was done to be able to solicit information from our village residents on their level of support for this ordinance. We plan to have a specific meeting that our residents will be encouraged to attend to provide their input on Prop 1 and our local ordinance. The first of these meetings will be held in March or April of 2019. We also intend on utilizing surveys to solicit input on this topic.

### Local Government Board Openings
